PROYECTO DE DECLARACION

LA HONORABLE LEGISLATURA TERRITORIAL

DECLARA:

ARTICULO 1º: Que vería con agrado que el Poder Ejecutivo Territorial interceda ante el Municipio de Ushuaia y conceda un prórroga mínima de seis meses a las familias que se encuentran transitoriamente habitando en el Albergue de la Juventud, lindante con el Centro Deportivo Ushuaia, para que puedan permanecer en ese edificio.

ARTICULO 2º: A su vez, que el Gobierno Territorial procure una solución definitiva a esta situación, pues desde hace tiempo están viviendo en ese lugar en total hacinamiento, lo que se constituye en hecho prioritario a ser tratado por la circunstancia excluyente de evitar el diario sufrimiento de familias con hijos pequeños que reclaman el derecho de una vivienda digna.-


