DECLARA:

Artículo 19.- Que vería con agrado que el Sr. Ministro de Relaciones Exteriores y Culto, Lic. Don Dante Mario CAPUTO, informe a esta Honorable Legislatura sobre aspectos que hacen a la mediación/Papal por el Beagle y a la política Exterior Argentina con relación a la integración con la República de Chile y al conflicto con el Reino Unido de Gran Bretaña e Irlanda del Norte, sobre las Islas/Malvinas.-

Artículo 29.- A los fines de lo indicado en el Artículo 19, la Honorable Legislatura recibirá los informes en Sesión Especial, a celebrarse en fecha coincidente con la visita del Sr. Ministro a la ciudad de Ushuaia.-


FUNDAMENTOS
